His Excellency:—I am very much obliged to you, Gentlemen, for your attendance here to-day, and I am specially obliged to you for allowing the Loan Ordinance to be taken through all its stages at this meeting. I declare the Council adjourned sine die.

His Excellency:—There is a further Bill entitled "An Ordinance for raising the sum of £3,000,000" which does not appear on the Agenda and copies of which it has not been possible to circulate to Honourable Members before this meeting. It is an urgent Bill and I am going to ask the Acting Secretary of the Southern Provinces and Colony to be so kind as to move the suspension of the Standing Rules and Orders of the Council to the extent necessary to take the Bill through all its stages. After he has done that, I will, on the second reading, explain the circumstances which have necessitated the introduction of the Bill, and ask the indulgence of Honourable Members to allow it to be passed at this meeting.

The Acting Secretary, Southern Provinces and Colony:—I move that the Standing Rules and Orders of the Council be suspended to the extent necessary to deal with a Bill entitled "An Ordinance for raising the sum of £3,000,000" as an urgent one.

The Acting Principal Medical Officer seconded.

Motion put and carried. Standing Rules and Orders suspended accordingly.

The Acting Secretary, Southern Provinces and Colony:—I move the first reading of a Bill entitled "An Ordinance for raising the sum of £3,000,000," so far as the provisions thereof relate to the Colony.

The Acting Principal Medical Officer seconded.

Motion put and carried. Bill read a first time accordingly.

The Acting Principal Medical Officer seconded.

His Excellency:—I must crave the indulgence of Honourable Members in regard to this Bill, in that it is not in their possession, but it is the ordinary form of Loan Bill which has been passed here over and over again. The circumstances are these. At the last meeting of the Council in August, when the question of increased taxation was before the Council, I explained that, in a very short time, we should have to raise money to carry on the large programme of Public Works to which we were committed, the cost of which amounts, in the aggregate, to between £12,000,000 and £13,000,000. Those are loan works. I said that the expenditure on these works during the current financial year was estimated at about £3,000,000, that it had been hoped to meet it, to a very large extent, from reserves, but that, owing to the falling off in revenue since the beginning of the year, it had not been possible to do this. I added that, so far as I could see then, we should have to borrow money to carry on the works until the end of the financial year.

I have been in communication with the Secretary of State with regard to the raising of that money, and a few days ago I received a cablegram from him to the eff. that the present was a favourable opportunity to go into the market to raise a loan, and as far as I understand, this course is being adopted at the present time by several Colonies. The Secretary of State thought that it would be in the interests of this country if the necessary Ordinance were passed to enable the Crown Agents to raise a loan of £3,000,000. That amount will only take us, as I said, to the end of March next, and sometime during 1922 it will be necessary to issue a further instalment of the total borrowings which will eventually amount to £13,000,000.

If the Council will be so good as to let me read the Bill to them and allow it to be taken through all its stages at this meeting, I shall be very much obliged. As I said, it is the ordinary form of Loan Ordinance which has been passed in this Council from time to time. I will now read the Bill. (His Excellency reads the Bill.)

The third section is an interesting one; it is taken from the Southern Nigeria Loan Ordinance, 1911. Under the Loan Ordinance, 1919, we were required to begin the contributions to the Sinking Fund six months from the date of the first issue of Stock. Now we go back to the old principle that we do not commence contributions to the Sinking Fund until three years from the date of the first issue of Stock, the Sinking Fund being so calculated and appropriated that the full sum required for the repayment of the loan will be available at the end of 50 years which I presume is to be the term of the loan.

The fourth section is also an old one, and is taken from the Southern Nigeria Loan Ordinance, 1911.

The Schedule is arranged so that the works which are in progress now may be financed until the end of this financial year, that is, until the 31st of March next.

Motion put and carried. Bill read a second time accordingly,

His Excellency:—This Order in Council reproduces the first schedule to the Customs Tariff Ordinance, 1916, as substituted by Order in Council No. 28 of 1919 and amended by subsequent Orders in Council. I will therefore enumerate the principal changes.

Section 2, sub-section (4).—It is proposed to raise the duty on gunpowder from is, to is, 3d, alb.

Section 3.—It is proposed to raise the duty on beads, the importation of which has largely increased of late, from 2d. to 6d. the lb. gross. This represents an has largely increased of late, from 2d. to 6d. the growing importations to which ad valorem duty of 15% which is justified in view of the growing importations to which I have alluded.

Section 11.—It is proposed to raise the duty on kerosene and fuel oils from 3d, to 6d, the Imperial gallon. The new duty is the same as that which has been in force on the Gold Coast for the past four or five months.

Section 14.—It is proposed to raise the duty on matches from 2s. to 2s. 6d. a gross of boxes, and the additional duty from 1s. to 1s. 3d. a gross.

Section 17.—It is proposed to raise the duty on soap from 3s, to 4s, a cwt, which represents an ad valorem duty of 7%; and on perfumed or medicated spirits from 30s, to 35s, an Imperial gallon. This follows the increased duty on spirits introduced last June. There has been a large increase in the importation of medicated introduced last June. There has been a large increase in the importation of medicated spirits and at the beginning of 1920 it was thought that medicated spirits were taking the place of trade spirits with the people, especially in the old Eastern and Central Provinces.

Section 20.—Tobacco. It is proposed to raise the duty on cigars from 4s. to 5s, a 100, a comparatively small duty; and on cigarettes from 1s. 3d. to 1s. 6d. a 100, which is the duty now in force on the Gold Coast; on manufactured tobacco from 1s, 6d. to 2s, a 1b, and on unmanufactured tobacco from 1s, 3d. to 1s. 6d. a 1b., or half 1s, 6d. to 2s, a 1b, and on the Gold Coast.

Honourable Members are aware that a large programme of Public Works is now in progress. Work on the Eastern Railway extension has been re-started and on a branch from that section to Bukuru. The cost of these two extensions is estimated at £8,631,000, exclusive of the cost of the bridge which is to be built across the Benue at or £8,631,000, exclusive of the cost of the bridge which is to be built across the Benue at or mear Abinsi. The final designs and estimates of the bridge are not yet complete, but the magnitude of the work of construction is such that it will not be possible to finish the bridge until 1928. Mr. Graham hopes to have the embankment completed as far as the Benue early next year.

An expensive scheme for the re-laying of the main line from Iddo to Ibadan, at an estimated cost of £1,107,000, is in hand, and re-laying from Minna to Kaduna (with re-construction of bridges from Minna to Zungeru), at an estimated cost of £885,000, re-construction of bridges from Minna to Zungeru), at an estimated cost of £885,000, re-construction of the Government to enable the heaviest locomotives to run over the has been forced on the Government to enable the heaviest locomotives to run over the entire section from Lagos to Kaduna.

The estimated cost of carrying out the new wharfage scheme at Apapa is £800,000 in round figures. The contract has been let to Messrs. Armstrong Whitworth & Co. The railway line has to be doubled from the new junction station to Apapa at a cost of £102,000, a new railway yard has to be laid out at Apapa, and will cost £57,000. The new workshops at Ebute Metta will cost £600,000. Messrs. Armstrong Whitworth & Co. have been given the contract for the workshops also. A light and power station under construction on Iddo Island, for the improvement of the lighting of Lagos and the supply of power to the railway workshops, will involve an expenditure of £240,000; and the coal and petroleum wharf, Iddo, £247,000. Another light and power station is being erected at Enugu for the railway and working the colliery, at a cost of £125,000. For the new dredger for Lagos Harbour, £327,000 will be required. Our total commitments on the whole programme amount to between £12,000,000 and £13,000,000. Of this sum, £3,000,000 is estimated to be spent during the current financial year. It was hoped to finance some of these works from revenue, but owing to the grave shrinkage of revenue, unless marked improvement is shown in the near future, we shall, at a very early date, require a refund from loans of any sums lent from the balances for these works.

A period is approaching when we shall have to have between £50,000 and £60,000 to pay for the money obtained by the Crown Agents, whether as an advance or otherwise, to carry on these works until the end of the financial year. The expected
