b. Why do you think that legislative reports should be standardised in the National

Assembly? (2marks)

c. Identify and briefly explain any five (5) types of legislative reports in the legislature.

d. Prepare the template for writing any one (1) of the legislative reports in the National Assembly (3marks)

e. Briefly discuss the procedure by which a legislative report is transformed into a resolution by the House of Representatives in the National Assembly. (3marks)

Question Four

a. Identify five (5) factors that may promote an effective Committee system in the National Assembly. (5marks)

b. Identify (5) qualities of a chairperson of committee in the legislature. (2.5marks)

c. Identify (3) challenges facing legislative committees in the National Assembly and suggest appropriate solutions to the challenges you identify. (6marks)

d. Identify (4) legislative support staff and state their job description. (4marks)

Question Five

a. Why do you think that Committees are necessary to conduct the business of Legislatures? (2marks)

b. Identify 5 functions of Legislative Committees. (5marks)

c. Briefly explain how Legislative Committees carry out their duties. (2.5marks)

d. Assuming you are the Clerk of one of the Legislative Committees in the Nigeria National Assembly, and you have been requested to make a presentation to newly recruited staff of the Assembly on the duties of Committee Clerk. Prepare a highlight of your presentation. (5marks)

e. Briefly discuss the role of Committees during plenary proceedings. (3marks)
