meeting, attended by the management staff of the Institute, include the need to certify some of the courses offered by the Institute. The National Institute for Legislative Studies' Act gives it powers to act as a centre for continuing education on democracy and legislation. Another mandate which is reflected in the work plan is "to conduct periodic training on democratic principles for members of the Armed Forces". Also discussed was the approval obtained by the Institute from the Independent Electoral Commission to monitor elections — another mandate of the Institute. In this regard, selected staff of the institute will participate in monitoring the 2015 general elections in Nigeria.

The Institute is further intensifying training programmes for legislators in the 3rd and 4th quarters of 2015 due to a possible high turnover from the results of the general elections. Worthy of note is an induction course that will come up in the first quarter of 2015 for legislators from both National and State Assemblies.

The Director General also informed the meeting that the 1st matriculation ceremony

of the NILS/UNIBEN postgraduate programmes will take place later in the month - another milestone in the fulfilment of the mandate of the Institute. The postgraduate programme is a unique opportunity for drafters, legal officers, policy makers and those interested in the process of law making and in drafting to acquire postgraduate certificates in line with the National Universities Commission's guidelines.

The Institute is also taking more robust steps to ensure delivery of more training for State Assemblies. These will include rigorous marketing of the Institute and distribution of training brochures throughout the country.

Dr. Ladi Hamalai challenged researchers at the Institute to come up with budget analysis way ahead of time to enable them carry out a budget retreat that will involve the law makers and in turn assist in the overall development of the nation. She reiterated the need for the Institute to build a strong and reputable name through its qualitative programmes, staff commitment and publicity. She also emphasized the need to carry out a monthly internal retraining for researchers to boost their capacity which will in turn lead to an improved department.

The Senate resumed plenary on Tuesday October 14, 2014 after a two weeks Sallah break and passed into law two bills entitled "National Health Bill 2014 and Federal University of Petroleum Resources, Effurun (Establishment, etc.) Bill, 2014".

The National Health Bill was passed into law by the two chambers of the National Assembly a few months ago but with differences that informed the setting up of a Conference Committee of both Chambers to harmonize the differences and report back to them. Having successfully ironed out the differences, the Senate Conference Committee led by Sen. Ifeanyi Okowa presented its report before the Chamber for consideration and passage into law.

# THIS WEEK IN THE SENATE

This week the Senate sat from Tuesday 14th to Thursday 16th of October, 2014

2014 Bill was presented before the Senate by the Committee on Education Chaired by Sen. Uche Chukwumerije. Sen. Shola Adeyeye presented the report on behalf of the Committee for the Chamber's consideration and passage into law. Sen. Adeyeye disclosed that the Bill was one of the bills sponsored by late Sen. Pius Ewherido which seeks to confer on the newly established Petroleum Resources University the Constitutional Legal Backing for its degree programmes. He added that the legislation seeks to enact an enabling law that will legitimizes the academic programmes of the University that has taken up long ago.

The plenary session of the Senate on Wednesday October 15, 2014 witnessed the passage of Four Bills for Second Reading and the adoption and approval of One Conference Committee Report. Also, the Red Chamber has received, adopted and the approved the Conference Committee Report on Discrimination Against Persons with Disabilities (Prohibition) Bill 2014 (S.B. 77) recently passed into law by the Senate and the House of Representatives but with differences. The report was presented by Senator Adamu Gumba. The harmonized bill was put to question and passed into law by the Hallowed Chamber.

Furthermore, the Senate has received from Mr. President the 2015 – 2017 Medium Term Expenditure Framework and an Executive Bill that sought to provide Financial Provisions by the Federal Government to equip the Nigeria Police to meet its constitutional obligation. This was contained in a letter addressed to the Senate President which was read on the floor of the Senate.

The Senate on Thursday October 16, 2014 at plenary passed four bills for Second Reading and stood-down three bills. The four bills that progressed to the next legislative stage had to undergo the normal legislative process of debate in which the general principles of each bill was deliberated upon by Distinguished Senators and at the end of the debate their fate determined through vote.
