

NILS COMMENDED FOR FULFILLING MANDATE

The President of the Senate, David Mark, has commended the National Institute for Legislative Studies (NILS) for judicious utilization of limited resources at its disposal. He said NILS is gradually doing what is expected - being a Centre for research and institutional memory. The Senate President made these remarks at the unveiling of the book series titled "A Century of Lawmaking in Nigeria: 1914 - 2014, Vol. I - IV" published by the Institute as its contribution to Nigeria's centenary celebration. Sen. Mark noted that what NILS is doing for the legislature in Nigeria is very significant to the sustenance of democracy, adding that "if democracy fails, the legislature suffers same fate". He called on other institutions in the country to emulate the excellent performance of NILS. He also encouraged the management and staff of NILS to do more research so that the national parliament can have a robust reference point. Speaking at the event, the Director General of NILS, Dr. Ladi Hamalai, described the book as not just a contribution to centenary celebration, but a historical revolution. She hinted that the Institute under her leadership staff were motivated to undertake the tedious compilation of bits and pieces of legislative history in Nigeria from 1914 to date. Dr. Hamalai added that both old and new legislators will no doubt benefit from the reservoir of legislative knowledge which the book contains. She pointed out that NILS is also presenting alongside the book, 3 other publications focused on Committees in the National democracy Assembly, Legislative functions, 2003 - 2013 and the legislature and democratic governance in Nigeria. NILS DEVELOPS GENDER STRATEGY FOR NATIONAL ASSEMBLY

In a bid to strengthen the National Assembly's response to gender and human rights in Nigeria and to create equal opportunity for all citizens irrespective of sex, disabilities and social status, the National Institute for Legislative Studies (NILS), with support from development partners such as Democratic Governance for Development (DGD), United Nations Development Project (UNDP) and the International Republican Institute (IRI). Gender mainstreaming strategy will assist the legislators to aim for gender awareness in their decision-making, it will also improve the capacity of officials to provide gender sensitive information and ensure that personnel policies and practices are gender inclusive. It is on this premise various stakeholders were invited what was tagged "Leadership and Agenda Setting Forum for Women Candidates of Political Parties" to provide foundation for deeper gender dialogue with the 8th National Assembly and with women who may emerge on other platforms. The forum was held on Monday, 15 December 2014 in Abuja. In her keynote address, Hon. Mulikat Akande-Adeola, Leader of the House of Representatives, recapped that in February 2014, her office convened the Nigeria Women Strategy Conference and followed it up in June with a Stakeholders meeting to concretize commitments to the resolutions that provided female politicians and advocates with a direction for expanding the political space for women. She restated her excitement in knowing that through definite and purposeful partnership, the agenda setting forum provides a platform for generating ideas and action for female candidates endorsed by their respective parties and accepted by the Independent National Electoral Commission (INEC). "This Forum will focus on themes that lend women candidates' solidarity and better prepare them for the race ahead", the House Leader added. In her goodwill message, the Director General of NILS, Dr. Ladi Hamalai, pointed out that the key objective of the forum was to galvanize

action and assistance for women candidature and participation in politics across all political parties. "Through the agency of this forum, we hope to build momentum increased women's political participation in the 2015 elections" she declared. On the gender strategy, Dr. Hamalai said it builds upon key findings from a gender audit of the National Assembly. She said both the forum and the gender strategy are geared towards identifying and categorizing the series of actions which political parties can take to support women's participation in different phases of the electoral cycle. Other notable goodwill messages were given by the representatives of DGD, Mintwab Zalelew, and IRI, Robina Namusisi. Participants at the forum, which is the first of its kind, included women affairs committees from both the House and the Senate. women in parliament, State level female party and legislative leaders, representatives from the Ministry of Women Affairs, Nigeria Women's Fund, 100 Women Group, NHRC, INEC, CSOs, UN Women and the media.

In his keynote address, he said the conference will help initiate an action plan for reviewing the Standing Orders of both Federal State Assemblies with a view to bringing them to standard. He identified some of the gray areas to focus on, such as amendment of the Constitution, convening a joint session where the President declines assent with regards to money Bills, said the rules are

inadequate as to how the parliament could override the President's veto. Other areas of constraint, identified by Sen. Enang was that members do not get to see the clean copies of Bills read the third time and passed before it's transmitted to Mr. President for assent.

Sen. Enang called on the Attorney General of the Federation, DG of Budget Office and the Minister of Finance to start paying adequate attention to the provisions of the law in relation to way and manner the National budget is prepared and presented

to the National Assembly. He advised for NILS to endeavor to tackle some of these challenges before the incoming legislators are inaugurated in 2015. Other resource persons who made insightful technical assessment of what is obtained in other jurisdictions with respect to rules of practice and procedure were Chairman, House Committee on Rules and Business, Hon. Albert Sam-Tsokwa, Former Clerk to the National Assembly, Mr. Ogunyomi Oluyemi and Mr. Dan Wandra Ogalo, a consultant from Uganda.
