

Commonwealth Secretariat Supports NILS On-Line Masters

The National Institute for Legislative Studies (NILS) is set to collaborate with the Commonwealth Secretariat in the area of Legislative Drafting online Masters' Degree Programme.

The Legal Adviser in the Rule of Law Division of the Commonwealth Secretariat, Ms.Segametsi Mothibatsela who visited the Director General of the Institute, Dr Ladi Hamalai in her office in Abuja recently expressed the Commonwealth Secretariat's enthusiasm about rendering assistance to member states.

The partnership will take the form of training and mentoring for the Institute's Legislative Drafters as well as provision of software relevant to the online Postgraduate services rendered by the National Institute for Legislative Studies in affiliation with the University of Benin.

Dr Hamalai informed that the Institute has already developed the training materials for Legislative Drafting which has been approved by the National Universities Commission; however, the online adaptation of the approved software requires support of the Commonwealth Secretariat.

While in Nigeria, the visiting representative also paid a courtesy call on the Clerk to the National Assembly, the acting Chairman, Law Reform Commission and the Legislative Drafting Department of the Ministry of Justice.

In the Chambers Last Week

On Tuesday 24, November 2015 Federal lawmakers in the House of Representatives have decried violation of the Nigerian Oil and Gas Industry Content Development Act of 2010 which was enacted to ensure that all operators engaged in any project in the Oil and Gas sector give priority to Nigerian as a significant element of their overall project development and execution. Following a motion moved in this respect by Hon. Lovette Ederin Idisi during plenary, the House called for investigation of the violation of the Grant of Right of First Refusal in the award of contracts in the sector. It was on this note that the Committee on Petroleum Resources (Downstream) and Committee on Local Content were charged to investigate the matter by inviting the Nigerian Content Monitoring Board, the National Petroleum Investments Management Services, the Department of Petroleum Resources and the Nigerian National Petroleum Corporation to appear before the Committee to explain what is described as the perennial violations of the Local Content Law by failing to grant right of first refusal to indigenous companies qualified to take the jobs. The Senate on the same Tuesday

passed for second reading the 2015 Supplementary Appropriation Bill entitled "A Bill for an Act to authorize the issue from the Consolidated Revenue Fund of the Federation the total sum of N465, 636, 926, 857 (Four hundred and sixty five billion, sixty hundred and thirty six million, nine hundred and twenty six thousand, eight hundred and fifty seven naira) only, of which N460, 636, 929, 857 (Four hundred and sixty billion, six hundred and thirty six million, nine hundred and thirty six million, nine hundred and twenty nine thousand, eight hundred and fifty seven naira) only is for additional recurrent (Non-debt) expenditure. While the balance of N5, 000, 000, 000 (Five billion naira) only is for contribution to development fund for additional capital expenditure for the year ending on 31st December, 2015". Senate Leader, Muhammed Ali Ndume led the debate and was seconded by Sen. Adamu Aliero. Similarly, three Motions were deliberated upon and passed with various Resolutions of the Senate. The Motions include; the current fuel scarcity all around the country and the need to urgently resolve the crisis, sponsored by Sen. Barau Jibrin (Kano North). The second Motion passed was titled "The need to Publish Accident Investigation Reports", sponsored by Sen. Theodore Orji (Abia Central). Finally, the third Motion passed by the Red Chamber was captioned "Police Recruitment", sponsored by Sen. Isiaka Adeleke (Osun West). The Motion expressed worry that Nigeria is grossly underpoliced, stressing that a country of 170 million people can only boast of a paltry 305, 579 policemen and women. The following day Wednesday 25th of November, 2015, The House of Representatives demonstrated its support to discourage all forms of violence against women by passing a resolution pledging its determination to continue to legislate against all sorts of violence against women. This came on the heels of a motion calling for the House to join the rest of the world in observing the day, moved by the Chairman, House Committee on Women Affairs, Hon. Stella Oduh. She sought the leave of the Speaker, Rt. Hon. Yakubu Dogara to inform the House that November 25, is the day set aside by the United Nations to celebrate elimination of violence against women. She implored her colleagues to unanimously support the prayers of her motion that called for a public complaint desk to be created in the Local Government Councils across the country, to entertain and respond to cases of violence against women in Nigeria. Another matter that was brought to the fore under matters of urgent public attention, was a motion calling for investigation of the status of personnel strength of the Nigeria Police Force. The call came at the instance of a motion that was moved by Hon. Ahmed Yerima, who exposed that about 90,000 policemen have



lost their lives since the inception of insurgency in Nigeria. He appealed that given the shortfall in the personnel size of the Nigeria Police, there is need to increase the number of the projected 10,000 men, which was recently approved by President Muhammed Buhari to be recruited into the Force. The House also has urged the Federal Government to invest more in Information and Communication Technology (ICT) so as to improve efficiency of the Nigerian Customs Service (NCS). The resolution also urged the Comptroller General of Customs to deploy more personnel to the borders in order to curtail activities of smugglers; adding that the Customs Service should shun the practice of mounting road blocks in search of goods that already made their way into the country. The Senate on Wednesday November 25, 2015 debated and passed for second reading "A Bill for an Act provide for the administration and political structure of Area Councils of the Federal Capital Territory and for related matters, 2015", sponsored by Sen. Philip Tanimu Aduda and seconded by Sen. Dino Melaye Similarly, the Senate has considered and passed a Motion entitled and passed a Motion entitled "Recurring Collapse of Bailey Bridges Nationwide", sponsored by Sen. Gilbert Nnaji (Enugu East). Leading the debate, Sen. Nnaji averred that the Bailey bridges were developed and used during the Second World War, they were built in Nigeria during the pre-independence and postindependence era up to few years after the Nigeria's civil war to provide temporary crossing for foot and vehicle traffic. He disclosed that the recent collapse of the Bailey bridges across Ebenyi River along Ikem Neke-Ugwuogo Road at Ikem-Uno in Isi-Uzo Local Government Area of Enugu State which took place on Friday November 6, 2015 calls for action. Rounding up plenary of the week on Thursday 26th of November 2015, The Speaker of the House of Representatives, Rt. Hon. Yakubu Dogara has averred that "any economy that does not innovate, cannot produce, but will remain perpetually consumers. The banks are doing very well making excessive profits, while the real sectors of the economy are suffering. Collusive behaviours of banks have kept the interest rate artificially high. This is the motion for the moment; this is where the change

starts". This statement added more weight to the resolution of the House during plenary session deploring the high interest rates being charged on lending by commercial banks in Nigeria and mandating the Committee on Banking and Currency to investigate the interest rate with a view to arriving at measures that will reduce lending interest rates to a single digit. The resolution came on the heels of a motion calling for regulation of lending interest rates charged by commercial banks, standing in the name of Hon. Bode Ayorinde. He pointed out that it is an obligation for financial institutions to play prominent role in providing financial services that consequently lubricates the economies of nations. Adding that Government alone cannot provide all the necessary financial needs of the economy. He informed the House that currently the banks pay between 2% to 3% interest on savings, whereas they charge alarmingly high interest rate of 23% and 28% on lending.

Meanwhile, the House has directed its Committee on Aviation to invite the Honorable Minister of Aviation to appear before it to explain what has been done about the discriminatory and unfair disengagement of Nigerians from the employ of Virgin Atlantic Airline. The directive came following a motion moved by the leader of the House Hon Tomic leader of the House, Hon. Femi Gbajabiamila, calling the attention of the House to the matter. He insisted that urgent action needed to be taken on the issue because it borders on the test of the resolve of the House of Representatives. He said this against the backdrop that barely two weeks ago, a resolution was passed on same matter by the House. The plenary session of the Senate on Thursday November, 2015 witnessed the consideration consideration and confirmation of Engr. Prof. Umaru Garba Danbatta for appointment as Executive Vice Chairman of the Nigerian Communications Commission (NCC) and also the confirmation appointment of Managing Directors of AMCON

during a sensitization workshop hosted in Abuja to discuss the role of the National Assembly in addressing the challenges of internal displacement in the country. While assuring her partners of the full support of the institute to assist in lifting the pains of IDPs, she seized the opportunity to call on relevant Committees of the National Assembly and indeed all interested organizations to take advantage of the resources at NILS in addressing the issues of internal displacement. She applauded the advocacy drives of both Chambers of the National Assembly in this regard and went on to implore the legislature to expedite action to develop a legal framework that guarantees assistance and protection for the IDPs. "We that are from the most affected States in the North, are fully aware of the dehumanizing conditions of these victims of insurgency" she added. In another development, Dr. Hamalai shared her experience with some Committee Clerks of the National Assembly at a Validation workshop

which was organized by NILS to assess the capacity needs of the National Assembly. She added her voice to espouse two separate and comprehensive presentations done by professors, Mike Obadan and Samuel Egwu. In her submission, she averred that comparatively to what is obtainable across parliaments globally, the National Assembly does not measure up, in terms of physical infrastructure, Information and Communication Technology, Research Support Services, Capacity of Legislative Aides and availability of working structures. The DG informed that things are pretty organized and predictive in the U.S Congress for example than in Nigeria. "Oversight functions are made easier because of availability of structures in place at the disposal of the legislators" she stated. She blamed the poor performance of legislative Aides on the fallen standard of education in the country and implored the lawmakers to push for reform in the education sector.
