
The committee, which consists of notable professionals like Prof. C. O. Okonkwo, Prof. Okechukwu Oko, Prof M. Jamo and retired Assistant Inspectors General of Police, Barrister Felix Ogbaudu and Barr. J.A Ishola, worked with other Legal research staff of the Institute to produce insightful amendment into the provisions of the Police Act and made some recommendations to the newly enacted Administration of Criminal Justice Act of 2015. While receiving the report in her office, Dr Hamalai commended the team for their work and contribution to national development. She reiterated the commitment of the National Institute for Legislative Studies (NILS) in offering to legislators and the legislature qualitative analytical work, relevant policy and information briefs.

"Nils plans to take advantage of the large market for legislative capacity development in

the country and beyond", she said.

#### Dr. HAMALAI TASK STAFF ON SUPPORTING LEGISLATIVE FUNCTIONS

In a swift reaction to the perceived disconnect between the expectations of legislators and the research and policy work of the National Institute for Legislative Studies (NILS), the Director General of the Institute, Dr. Ladi Hamalai came hard on staff of core departments comprising of the Legislative Support Service and Research and Training, charging them to reorganize their research activities, ready to produce consumable and popular research works to meet the expectations of Legislators. She stated in an interactive meeting with the Heads and Staff of the Departments on Monday 7, December 2015, that 90% of the Institute's research work is not utilized by Legislators because they are not focused on Drafting Bills and Motions, Bills reports, policy briefs, data briefs and training. Dr. Hamalai proposed new strategies including designing of recruitment policy; adjustment of the service scheme to enable proper implementation of the reforms. She further urged the Directorates of the Institute to change work plan strategies and targets as well as reshuffle the staff of their Departments with a view to identify their areas of specialization.



# In the **Chambers Last Week**

Lawmakers in the House of Representatives has called on the Federal Government to, as a matter of urgency do what is necessary to provide vaccination and as well increase public awareness for the prevention of the meningitis disease. A resolution was passed on the floor of the House during plenary on Tuesday 8, December 2015 following a motion at the instance of Hon. Abdulrahman Shuiabu Abubakar, calling for massive public enlightenment campaigns on the scourge of the disease and encourage people to inculcate the culture of basic hygiene into their lifestyles to reduce transmission of the bacteria that causes meningitis. The House also passed for second reading A Bill for an Act to Provide for the Establishment of the Chartered Institute of Export and Commodity Brokers of Nigeria and for Other Matters Connected Therewith (HB. 113) standing in the name of Hon. Uzoma Nkem-Abonta. The Bill was read the second time after the sponsor of the Bill lead a debate on the general principles of the Bill Meanwhile, the Speaker of the House, Rt. Hon. Yakubu Dogara announced that President Muhammadu Buhari has forwarded the 2016/2017/2018 Medium term and Fiscal Expenditure Framework alongside the o Pg2

Strategic Papers (MTEF/SP) to the House of Representatives for consideration. The document was accordingly referred to the Committee on Appropriations for immediate legislative inputs. The plenary session of the Senate on Tuesday December, 8, 2015 witnessed the consideration and passage of two Motions on the floor of the Red Chamber. The two Motions passed were: The Incidents of incessant bomb attacks in public places, sponsored by Sen. Rabiu Musa Kwankwaso (Kano Central) and was seconded by Sen. Abdul Aziz Murtala Nyako (Adamawa Central). Sen. Kwankwaso noted that the Economic and Peace Institute in its Global Terrorism Index 2015 has identified Nigeria as a country that has witnessed the largest increase in terrorist related deaths perpetrated by the Boko Haram Insurgents accounting for half of all the global deaths attributed to terrorism. Similarly, the second Motion passed was titled "The urgent need to Re-Assess Nigeria's Foreign Policy Objectives in line with Emerging Economic Realities", sponsored by Sen. Stalla Oduah (Anambra North) and seconded by Sen. Jonah Jang (Plateau North). Sen. Oduah noted that prior to Nigeria's independence in 1960, the nation's Fundamental Foreign Policy Principles have remained unchanged. Rather every administration in the country come up with New Circumstantial Mechanisms for achieving the country's foreign policy goals. Meanwhile, the Senate has received two petitions from a protesting group led to the National Assembly Complex by Ordinary Ahmed Musa. The petitions were sent to the Chamber through Sen. Enyinaya Abaribe and Sen. Shehu Sani who received the group on behalf of the Senate. The two petitions have laid before the Upper Legislative Chamber and have been referred to the Committee on Ethics and Privileges and Committee on Public Petitions by the Senate President.
The House of Representatives has on Wednesday, 9 December, 2015 committed the 2016 - 2018 Medium Term Expenditure Framework and Fiscal Strategy Papers (MTEF/FSP) to the committees on Finance, Appropriations, Aides, Loans and Debt Management for careful examination of the documents and timely submission of the report, which would subsequently guide debate on the documents on the floor of the House. Following the forwarding of the MTEF/ FSP documents to the National Assembly on Tuesday 8, December 2015 by President Muhammadu in compliance with sections (11) 1,2 and 3 of the Fiscal Responsibility Act, 2007 which provides that the MTEF/FSP shall be considered for approval with such modifications, if any, as the National Assembly finds appropriate by resolution of each House. The document estimated 2.2 million barrel of Oil per day, and benchmark of 38. Still on Wednesday's plenary, the House passed a resolution that mandated its Committee on Capital Market and Institutions to investigate the downward slide of the Nigerian Stoke Market and report back to the House within two weeks. The resolution was passed on the heels of a motion moved by Hon.



Abubakar Nuhu drawing the attention of the House to the dangers associated with the downward sliding of the stoke market, which he claimed has caused several investors to withdraw from the market. Adding that this portends a grave threat to the economy and has depreciated our currency in no small measure. The Senate on Wednesday December 9, 2015 considered and passed the 2016 2018 Medium Term Expenditure Framework (MTEF) and Fiscal Strategy Paper (FSP) sent to the Chamber by President Muhammadu Buhari yesterday. The Bill was presented for consideration by the Senate Leader, Muhammed Ali Ndume and was seconded by the Senate Minority Leader, Godswill Akpabio which paved way for debate on the general principles of the Bill. Similarly, the Red Chamberhas considered, approved and confirmed the nomination of Dr. William Babatunde Fowler for appointment as Executive Chairman, Federal Inland Revenue Services (FIRS). The confirmation was sequel to the presentation of his screening report by the Senate Committee on Finance led by Sen. John Enoh before the Upper Legislative Chamber for consideration and approval. The Speaker of the House of Representatives, Rt. Hon. Yakubu Dogara has reiterated the commitment of the 8TH House to bring to speed all laws of the Federation starting from the first Republic to date. "We have slated 130 Bills which will be passed for first reading today, and there are more in my office, any member who wishes to sponsor some of these Bills may indicate their interest. This unprecedented and remarkable commitment to bring our laws at par with modern Day realities must be encouraged, because for any change to stand the test of time, it has to come by way of legislation. These are the first set of intervention Bills in line with our legislative agenda", he stated. The Speaker said this during plenary session on Thursday 10, December 2015, adding that the Chairman, Committee on Rules and Business has been directed to slate at least 20 of these Bills that have scaled first reading, for second reading on the next legislative week. The House has also reacted to the plights of Nigerian students abroad who have been reported to have staged protests on the shear maltreatment being meted to

Nigeria. Following a motion calling for full payment of all stipends and allowances by the Federal Scholarship Board to the foreign students under the Bilateral Institutions Agreement which Nigeria entered into with counterpart countries, moved by Hon. Rita Orji, the House mandated its Committees on Foreign Affairs, Tertiary Education and Diaspora to engage relevant institutions and the Ministry of Education to find solution to the plights of the students. Meanwhile, the report of the ad-hoc Committee on the investigation of alleged abortion of recruitment of victims of 2014 Nigerian Immigration Service(NIS) recruitment was laid before the House for consideration. Rt.Hon. Yakubu Dogara stressed that due to the importance of the matter, the report would be considered at the plenary session to enable the House pass a resolution on it. The Senate on Thursday December 10, 2015 deliberated upon two legislations and passed same for second reading. The general principles of the Bills were exhaustively debated by distinguished Senators and thereafter the two Bills got the nod of the law-makers thus progressing to the second reading stage. The legislations that scaled through to the next legislative stage include: A Bill for an Act to Repeal Sections 59 – 69 of the Police Act CAP 359 LFN 2004 to enact the Traffic Warden Service and for Related Matters, 2015 (S.B. 100), sponsored by Sen. Buhari Abdulfatai (Oyo North) and seconded by Sen. Isiaka Adeleke (Oyo West). Similarly, an Act to Amend the Counterfeit and Fake Drugs and Unwholesome Processed Foods (Miscellaneous Provisions) Act CAP C34 Laws of the Federation of Nigeria and for other matters connected therewith, 2015 (S.B. 55), sponsored by Sen. Biodun Olujimi (Ekiti South) equally passed second reading on the floor of the Senate. The Bill which sought to amend and fortify the NAFDAC Bill is aimed at reducing the negative effects of counterfeit and fake drugs, foods and other unwholesome products amongst citizenry.


