REPORT OF THE PUBLIC ACCOUNTS JOINT COMMITTEE
OF THE NORTHERN REGIONAL LEGISLATURE : SESSION
1956-57

MR PRESIDENT,

The Committee have the honour to report that they have met and examined—

- (a) The Report of the Director of Audit on the Accounts of the Government of the Northern Region for the year ended 31st March, 1955.
- (b) The Report of the Auditors on the Accounts of the Northern Region Development Board for the period 1st April to 31st December, 1955.
- (c) The Report of the Auditors on the Accounts of the Northern Region Production Development Board for the period 1st April to 31st December, 1955.
- (d) The Report of the Auditors on the Accounts of the Northern Region Development Corporation for the period 1st January to 31st March, 1956.
- (e) The Jos Hill Station Accounts for the year ended 31st March, 1955.

2. The Lamido of Adamawa was unable to attend any of the sittings of the Committee which lasted from 4th to 9th February, 1957. The Emir of Ilorin attended the sitting on the first day but was unable to attend other sittings, while the Emir of Yauri was unable to attend the sittings on the first two days but attended the rest of the sittings.

REPORT OF THE DIRECTOR OF AUDIT ON THE ACCOUNTS OF THE GOVERNMENT
OF THE NORTHERN REGION OF NIGERIA FOR THE YEAR ENDED 31ST MARCH, 1955

3. *Paragraph 2.*—The Accountant-General undertook to make every effort to decrease the interval between the closure of the accounts and the production of the annual statements. In particular it was agreed that a copy of the Detailed Statement of Expenditure should be submitted for Audit as soon as possible, even if this entailed the omission of details of supplementary provision which had not, at the time of submission of the statement, as yet been approved.

4. *Paragraph 5.*—The Committee accepts the recommendation of the Accountant-General that the strengthening of strong rooms should be concentrated upon, rather than the provision of armed guards.

5. *Paragraph 6.*—The Committee recommends that efforts should be made to arrange surprise surveys by Treasury touring accountants.

6. *Paragraph 7.*—The Committee took note of a statement by the Financial Secretary that the accounting system of the North Regional Literature Agency had been greatly improved and that it is hoped to lay the accounts before the Legislature at the meeting normally held in August, this year.

7. *Paragraph 9.*—The Committee accepted an assurance from the Director of Public Works that, within the capacity of the staff available, checks would be made as frequently as possible on the larger and more important stores on construction sites.

8. *Paragraphs 10 and 64.*—It is understood that active consideration is being given in the Financial Secretary's Office to the issue of simple rules on how to safeguard Government cash and stores.

9. *Paragraphs 13, 14, 15 and 16.*—The Committee understands that the matters dealt with in these paragraphs have now been, or will shortly be, settled.

10. *Paragraph 17.*—Instructions concerning appointment and conditions of service of Government drivers have now been issued.

11. *Paragraph 18.*—The Director of Public Works undertook to draw the attention of the Officers concerned to the existing instructions for the handing over of buildings in order to avoid a recurrence.

12. *Paragraph 20.*—The Committee recommends that arrangements should be made between the Accountant-General's Department and the Audit Department with a view to the reduction of the number of items shown in Annexure I as 'No yet admitted'.

13. *Paragraph 21.*—The Committee recommends that consideration should be given to the possibility of withholding further payments to Officers who have failed to return outstanding vouchers. The Financial Secretary undertook to write to the Finance Ministeries of the other Regions to ascertain the position in those Regions. The Accountant-General stated that he expects that, as a result of a change of system in the release of vouchers for completion, a very considerable reduction in the number of outstanding vouchers for 1956-57 will be effected.

The Committee understands that the Federal Public Accounts Committee is considering the question of the disposal of long outstanding vouchers and therefore does not at present wish to make recommendations on this matter.

14. *Paragraph 22.*—The Committee accepted an assurance from the Accountant-General that further action would be taken as soon as circumstances permit.

15. *Paragraph 23.*—The Committee recommends that the importance of informing the Accountant-General of all secondments should be impressed upon Heads of Departments and that a prescribed form of notification should be employed.

16. *Paragraph 24.*—In view of the difficulties of collection of Hospital fees, the Director of Medical Services suggested that no charge should be made for maintenance in general wards but that where special accommodation was provided Hospital fees should be charged. The Committee recommends that this suggestion should be examined by the Government.

17. *Paragraph 25.*—The necessary authorities have been obtained.

18. *Paragraph 30.*—In each case the Officer in charge of the vote gave an assurance that every effort would be made to avoid unauthorised excesses in future. The Committee observed that in nearly all cases the delay in obtaining the necessary authority was largely due to failure to reconcile promptly departmental and Treasury records.

19. *Paragraph 34.*—The Director of Agriculture stated that considerable progress had been made in improving accounting arrangements at Mokwa.

20. *Paragraph 37.*—The Committee accepted an assurance from the Accountant-General that the internal check of Personal Emoluments records is now adequate.

21. *Paragraphs 46 and 49.*—The Accountant-General gave an assurance that vigorous efforts are being made to clear those accounts which still have outstanding balances.

22. *Paragraph 47.*—The Committee noted that, with six exceptions, outstanding balances had been cleared. In the case of the large number of balances transferred to the Accountant-General of the Federation, the Accountant-General, Northern Region, assured the Committee that these had been accepted.

23. *Paragraph 48.*—The Accountant-General explained the reasons for, and the steps that are being taken to eliminate, errors in classification, and assured the Committee that every effort is being made to improve the situation.

24. *Paragraphs 53, 55 and 56.*—The required statements have now been submitted.

25. *Paragraph 57.*—The fund has now been closed.

26. *Paragraph 59.*—The Accountant-General and the Director of Public Works both gave assurances that every effort would be made to dispose of the matter of the outstanding balance in the account of the Nigerian College of Arts, Science and Technology.

27. *Paragraph 61.*—The Accountant-General explained that the task of clearing the Home Allotment accounts had proved much more formidable than anticipated, but he hoped that before the next meeting of the Committee the latter would have been put in order.

28. *Paragraphs 65, 66 and 67.*—The Committee understands that all the individual cases referred to in the Audit Report have now been, or will shortly be, disposed of. Assurances were accepted from the Departments concerned that all possible efforts would be made to avoid similar delays in future.

29. *Paragraph 72.*—The Committee was assured that the accounts are now available for examination.

30. *Paragraph 74.*—The Committee recommends that the possibility of the Government's divesting itself of the responsibility for the running of the canteen should continue to be borne in mind.

31. *Paragraph 79.*—The Financial Secretary gave an assurance that the long outstanding queries referred for his assistance in settlement are vigorously pursued.

REPORTS ON THE ACCOUNTS OF THE NORTHERN REGION DEVELOPMENT AND
PRODUCTION DEVELOPMENT BOARDS FOR THE YEAR ENDED 31ST DECEMBER, 1955,
AND OF THE NORTH REGIONAL DEVELOPMENT CORPORATION FOR THE PERIOD
1ST JANUARY TO 31ST MARCH, 1956

32. The Committee is pleased to note that the Corporation's Auditors are prepared in future to furnish in their audit report more explicit information regarding the state of Audit of the Expenditure on schemes made by the Corporation. The Committee

accepted an assurance that a review of individual schemes, to determine what, if any, further auditing is required, will be effected in consultation with the Director of Audit, and that the latter will be informed by the Corporation of the accounting arrangements for all future Schemes which involve, or are likely to involve, Government or Native Authority accounts.

33. The Committee has no further comments to make on the accounts recorded in paragraph 1 above and sees no reason why these accounts should not be accepted by the House.

APPENDIX

MEMORANDUM BY THE FINANCIAL SECRETARY ON ACTION TAKEN ON THE REPORT OF THE PUBLIC ACCOUNTS COMMITTEE, SESSION 1955-56

The following action has been taken on the Committee's Report:—

Paragraph 3.—In this, the Committee expressed concern at the delay in submission of final adjustments to the Accountant-General, Northern Region by the Accountant-General of the Federation. The reason for the delay in receiving final figures from the latter is largely that the Regional share of the costs of various Federal Departments cannot be determined until all other Federal accounts have been finally closed. To remedy this, it has been suggested to the Accountant-General of the Federation that final adjustments to the figures of the Regional share of costs of Federal Department be carried out in the following financial year. This proposal has been accepted and the other Regions are being consulted. If adopted, the proposed new arrangements should result in the Accountant-General of the Federation being able to submit his final adjustment figures at least one month earlier than is now the case.

Paragraph 6.—The Unallocated Stores have now been Regionalised and a Senior Staff Storekeeper has been posted to Kano. This should improve documentation and control of stores.

Paragraph 8.—Revised instructions governing the accounting procedure to be adopted in hospitals have been introduced, in consultation with the Director of Audit, in Kaduna General Hospital. If they prove satisfactory there, they will be brought into force in other hospitals in the Region.

Paragraph 11.—The Accountant-General has issued instructions (Treasury Circular No. 17/1956) instructing Revenue Collectors to submit returns to their Heads of Departments, who will assemble them and forward them to Treasury Headquarters. A copy of the Treasury circular is attached. This should reduce correspondence and delays regarding outstanding revenue.

Paragraph 15.—Jos Hill Station Accounts for 1954-55 were laid on the Table of the Legislature at the 1956 Budget Session.

Paragraph 16.—Considerable progress has been made by the Accountant-General in clearing dormant balances from Advance Accounts. Government is considering whether the current complex system of calculating interest on advances can profitably be simplified.

Paragraph 19.—Action on clearing the Deposit Accounts in question has proceeded and progress has been made. Since 1st April, 1956 the Accountant-General of the Region is no longer responsible for dealing with the Home Allotments of Officers outside the Regional service and these difficulties should thereby be resolved, thus removing one source of difficulty regarding deposit accounts.

Paragraph 20.—All debit balances in Textile Centre Suspense Accounts have now been cleared by being admitted to expenditure through the creation of expenditure Sub-heads with the authority of the Regional Joint Standing Committee on Finance. These Centres will, in future, no longer be operated on Suspense Accounts but through the Estimates. New quasi-commercial schemes will not be undertaken without the most careful consideration of the accounting arrangements proposed.

Paragraph 24.—The new system for dealing with Treasury and Audit queries, introduced with effect from 1st April, 1955, has now been in operation for over two years and it is clear that a very considerable improvement has been effected, although the sheer volume of queries unfortunately makes it inevitable that some should be delayed.
