**Kaduna, Wednesday, 27th March, 1963**

1. The House met pursuant to the Proclamation of His Excellency the Governor of Northern Nigeria bearing date the twenty-eighth day of January, One thousand nine hundred and sixty-three, which proclamation was published as Northern Nigeria Notice No. 6 appearing in an *Extraordinary Gazette* No. 6, Vol. 12 of 28th January, 1963.

Premier, Alhaji Sir Ahmadu Bello, K.B.E., Sardauna of Sokoto went in procession to receive His Excellency the Governor, Sir Kashim Ibrahim, K.C.M.G., C.B.E., who, after inspecting the Guard of Honour mounted by the 5th Battalion of the Queen's Own Nigeria Regiment, entered the Chamber in procession and delivered the Speech from the Throne. His Excellency was then escorted out in the same procession.

**4. Announcement:**

Upon resuming his Chair, the Deputy President announced that he had received a letter from the President expressing his inability to preside over the meeting owing to sudden illness but wished the House successful deliberations. The Chairman announced the death of two members—the Chiefs of Mbula and Takum and congratulated the new Etsu Nupe. He welcomed the members and then asked permission to express to the President the members' deep regret over his illness and their wish for his speedy recovery.
