## **Question One**

(a) Order 77 (3) of the Senate Standing Orders 2011 (as amended in 2015), states that as a mandatory requirement every Bill should be accompanied by a compendium of background information and a Compendium of Financial estimates.

Write brief notes explaining how this is justified in comparative legislative drafting using the 2011 Steve Orasonye's Report of Rationalisation of Ministries, Departments and Agencies (MDA) as a case study. **(8.75 marks)** 

(b) Write brief notes on the how the two German lawyers evolved Comparative Law as a distinct area of study, what is the functionality theory in comparative law, provide an example of how the theory of functionality in comparative law can be applied in legislative drafting (use the UN Convention on the Rights of a Child, 1989 and the 2003 Child Rights Act as an example). **(8.75 marks)**
